2. AGENDA REVIEW AND ANNOUNCEMENTS

The August Agenda was accepted as proposed. Michael distributed a flyer about bringing back vintage trolleys. He also reported that the Little Italy fundraiser "When in Rome" was a great event.

4. TREASURER'S REPORT

ACTIVITIES PORTION OF MEETING

5. CAR SHOW

The Car Show will be in the parking lot behind the North Park Theatre. The event is scheduled for **Saturday**, **September 11 from 10 am to 1 pm**. We have 39 entries (and counting). West Coast Tavern will offer discounts, so be sure to go there for lunch after the show. Louise moved and George seconded to have a banner made at A7D, for cost of up to \$100. The motion carried unanimously.

Vince did a fabulous job on the poster! It is up around town thanks to Bill, Randy, Patrick, Paul, Sharon, Liz, Steve, Louise, and Jody (apologies if I forgot anyone). Special thanks to Paul for posting on Facebook and the website, and to Bill and Jody who handed out flyers at the NPCA concerts.

Helpers, please come to the parking lot at 8:00 am on Saturday. We need to set up the booth and signage, check in cars, direct drivers to their spaces, give them their display placards, and answer questions. When the show starts, we will gather groups of 10 or so who want to take a commercial walking tour at the booth and



send them off with George, Patrick, or Michael, plus some helpers in each group. Guides, don't forget your megaphones! We have a two-sided handout with a list of the 32 buildings and a map on the back for the free tours. Attendees can purchase the full guidebook for \$5 at the booth. Dress in your favorite decade or wear your NPHS tee (remember your name tag). Michael will bring a 2010 NPHS calendar to have at the booth as an example. Patrick and Michael will bring traffic cones. Vince is preparing a placard template and Katherine will finish and print.

Our District 3 Councilmember Todd Gloria is set to come at 12:15 to announce the winners of Best of Show and People's Choice and hand out trophies. Louise will take photos. Parking is abundant in the parking garage for only \$5 for the whole day.

6. BOOK PROJECTS

New Book, 1946-Present: The Book Group enjoyed the tour of St. Augustine on July 29. Thanks, Louise, for recording the event and taking great photos! The group will not meet in August so we can focus on the car show. Louise is set to meet with Jay Turner to learn more about how getting North Park recognized as an arts district was a big part of the renaissance.

7. CALENDAR

We reviewed the fact that those taking photographs do not need releases or permission from home owners as long as the pictures of buildings are taken from the public right of way. Once the calendar is finished and available, we plan to drop off a thank you/congratulations card at the selected houses to note that the building is featured and where the calendar can be purchased. The group will review photos and start compiling the calendar, with the goal to be ready to order in early October.

8. SHIRLEY ANN PLACE

At the July meeting, Jerry Kwasek presented information about the Shirley Ann Place Historical District. The North Park Project Area Committee (PAC) had recommended that Shirley Ann Place ask NPHS for direction and support regarding a district marker. We obtained additional information subsequent to the meeting, including that other historical districts are marked by signs, not structures. Also it is important to keep in mind that Shirley Ann Place is actually in the University Heights Historical Society "jurisdiction," so we should defer to their recommendations and position. Consistency among districts was considered to be important, and the Board voted unanimously to approve the motion by Patrick seconded by George to support a sign similar to those for the other designated districts. *Update: A letter for the PAC was prepared and distributed by email on August 24, 2010.*

9. OTHER BUSINESS

Steve and Katherine will staff a table for NPHS at the Burlingame Block Party on Sept. 11 starting at 4 pm. It's going to be a busy day!

The Taste of University Heights and University Heights Arts Open will be held on Sunday, Sept. 12 from noon to 5 pm at the Teachers Building Annex, 4100 Normal Street. NPHS will have a booth with other exhibitors on the lawn in front of this historic building. Ed, Jody and Sharon have volunteered to staff the booth that afternoon. Steve and Katherine will bring materials and help set up and take down. Parking is available in the lot behind the building off of Campus Avenue at Tyler Avenue.

On September 25 at 9:00 am, George and Patrick will lead a commercial walking tour for the Burlingame Club, subject to confirmation from the Club.
